## Leadership Team Message

This year, for the first time, LWVNM is being run by a leadership team in lieu of a president and vice president. Your team -- Dick Mason, Linda Moscarella, Meredith Machen and Joe Keefe -- invite you to State Council May 12 in Albuquerque. It's a morning meeting plus lunch with a speaker. (Read more in this issue of *La Palabra*.) The main purpose of Council is to review the budget and discuss issues that might have arisen since the last state convention. It is also a time to share news with each other, renew acquaintances and have some fun.

The state and the action committee have been busy during this year's short legislative session. Dick Mason reports (see page 6) that because of our

efforts, some of the worst outcomes on many issues of interest to the League (e.g. Voter Photo ID) were averted. A win was a Memorial calling for a U.S. Constitutional Amendment that would reverse the recent U.S. Supreme Court decision, Citizens United. League members enjoyed a lively and well-attended panel discussion on the issue of Voter Verification held at Garrett's Desert Inn the evening before League Day at the Legislature. The LWVUS Public Advocacy for Voter Protection grant funded this event.

# Reports by Cheryl Haaker

## Redistricting Committee

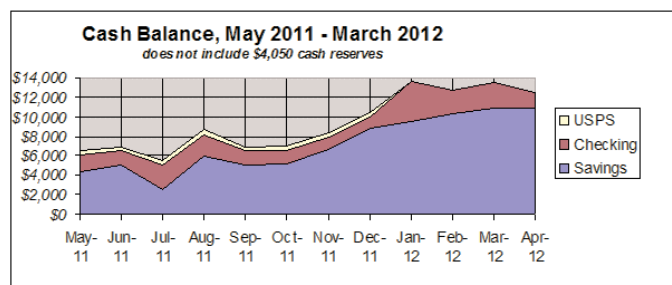
Last summer, the State's Redistricting Committee held a series of public meetings throughout the state where options for new redistricting maps for the Congressional, state House and Senate and Public Regulation Commission were displayed. Members of the LWV (Judith Binder, Bonnie Burn, Lisa Franzen, Barbara Goedecke, Joe Keefe, Gayle Prinkey, Shelly Shepherd, Delores Watkins, Judy Williams, Mary Wilson and others) were present at these meetings and gave statements. Joe Keefe, the LWVNM Communications Chair, recorded complete videos of all the meetings and gave copies for the state to post on its website so that the public could view the meetings at will.

In Las Cruces, League members worked with city councilors and county commissioners during their redistricting processes. Three members -- Jane Asche, Al McBrayer and Diane Prindeville -- served on the independent Ad Hoc Committee appointed by the mayor and city council and made sure that the committee's recommendations were heard. Bonnie Burn was the League observer at the Dona Ana County meetings.

In Santa Fe, the county requested that the League be included in their redistricting meetings. Santa Fe League has established a presence in local government by its internationally-known Transparency Study and by sending observers to meetings and forming relationships with elected officials and staff.

## Treasurer's Report

**Operations Fund:** The League's assets are near their annual maximum at present. All PMP payments are in, and reimbursement requests for National Convention have yet to arrive. LWVNM received a \$5,000 grant from National for PAVP



(see article in this issue), and has not yet spent it all. We have canceled the USPS postal account, which saves the \$200/year fee and are piggybacking on LWV CNM's postal account when we send out mass mailings. These mailings have been dramatically reduced, since *La Palabra* is going out mainly by email this year. As can be seen by the chart, the bulk of the League's assets are kept in the savings account, with just enough in checking to meet the minimum balance requirements and pay checks. This policy dates back to when savings accounts actually paid interest.

**Education Fund:** With the publication of the Voters' Key last year, the Ed fund is down to \$1,161.

## Board Meeting Highlights

**January 7, 2012** -- University of New Mexico Law School, Albuquerque, 10:30 a.m.- 3 p.m.

\* Treasurer Cheryl Haaker presented the Treasurer's report. She said there was a total of \$13,647.26 in the bank accounts, including \$9,495.28 in the Wells Fargo savings account and \$4,151.98 in the Wells Fargo checking account.

\* Dick Mason said that League Day at the Legislature will be Jan. 24, 2012. League Day will start at the Capitol. Members are encouraged to attend sessions in the House and Senate and/or committee hearings before 10:30 a.m. when they will hear from a panel talking about the 30-day session.

\* Mason said legislators will be invited to the educational forum/reception Jan. 23. There will be a panel of experts who will discuss the facts that counter the generalizations and distortions regarding voter fraud. This event has been coordinated with the New Mexico Election Administration Coalition and is being paid for by a grant the LWVNM received from the National League of Women Voters Education Fund to educate the public and legislators about

Protection and Advocacy for Voting Access (PAVA).

\* Mason provided a list of bills the LWVNM will be watching over the course of the legislative session.

**March 17, 2012** -- REI meeting room, Santa Fe, 10:30 a.m.-3 p.m.

\* Treasurer Haaker presented the Treasurer's report. A total of \$2,688.61 remains in the PAVP grant. She also said that she was unable to open an account with the New Mexico Educators Federal Credit Union because individuals signed on to the account have to be affiliated with a school.

\* Mason said that some 35-40 people attended League Day at the Legislature Jan. 24. He said it was a good event and there was also a full house at the reception/panel the evening before.

\* Mason said the organization Deliberative Democracy is planning to conduct a state-wide polling project to address the subject, "What public services do you want and expect from your government, and how do you wish them to be paid for."

# LWVNM Land Use

Since the adoption of the land use study at convention last year, two local Leagues have hosted meetings about aspects of the issue. Santa Fe held a panel discussion about "land use or misuse, pitfalls, rules and tools.". The Central New Mexico League heard from State Land Commissioner Ray Powell at a luncheon.

Subsequently the study committee has published two articles in *La Palabra*, one by Lora Lucero describing the history of land use laws in the state, and one by Barbara Calef about how the State Land Office works. The committee has much material still to cover and will require additional time to complete its work before bringing consensus questions to the local Leagues.

Recently we have been investigating the link between land use and environmental justice. The following preliminary report was written by Judy Williams and Barbara Calef

## **Land use and environmental justice**

One of the considerations that should guide decision-making regarding land use is the principle of environmental justice, which was developed in the United States in the early 1980's in response to the realization that landfills, including those containing hazardous waste, were largely located where the residents were members of minority groups, poorly educated, low-income, without political power. "Environmental justice is the principle that all people,

regardless of socioeconomic status, race or ethnicity, deserve to live in a clean, healthy environment." (Southwest Environmental Law Center)

Society and the economy demand the benefits of certain inherently polluting activities such as mining operations and solid waste disposal facilities. According to the tenet of environmental justice, the adverse impact of such activities must be mitigated equally for all communities, rich and poor.

In New Mexico, Native Americans have suffered from uranium mining as well as coal-burning power plants. Church Rock was home to the longest continuous uranium mining in any Navajo land. From 1954 until 1968, the tribe leased land to mining companies that did not obtain consent from Navajo families or report any consequences of their activities. Water supplies were depleted and contaminated with uranium. Kerr-McGee and United Nuclear Corporation, the two largest mining companies, argued that the Federal Water Pollution Control Act did not apply to them, and maintained that Native American land is not subject to environmental protections. The courts did not force them to comply with US clean water regulations until 1980. There didn't seem to be a lot of support for it, and \$80 a seat is a lot of money in this economy. She said the board also agreed to do a smaller event, maybe a Saturday lunch, later in the year.

\* The Board selected three people to attend

the national convention. They are Joe Keefe, Cheryl Haaker and Dick Mason. The convention is June 8-12 in Washington, D.C.

## **Jane Gaziano passes**

Jane Gaziano, president of LWVSFC from 2005-2007, passed away April 3. A celebration of her life will be held Saturday, April 14 at the Santa Fe International Folk Art Museum from 5:30 to 7:30 pm.

# Report of the LWVNM Action Committee for 2011-13

If I were to summarize the LWVNM view of the 2012 session in one sentence it would be, "We kept bad things from happening." Sometimes that is all you can hope for. We kept voter photo ID, repeal of the law allowing driver's licenses for the undocumented, reinstatement of the death penalty and parental notification for abortion from coming to a floor vote in either the Senate or the House.

The state budget that was passed did adequately fund Medicaid and other essential services. As always, it would have been better to see additional funding for these services. But after the cuts of the last couple of years, it was a relief not to have to fight just to maintain existing funding. This was a 30-day session, so the Legislature could only deal with budget items and issues that the Governor put on her "call." The Governor did not put any bills dealing with implementing federal health care reform on her "call." This was very

disappointing.

We did pass SB9, which required combined reporting for out-of-state corporations with "big box" stores in New Mexico. This would have leveled the playing field for New Mexico-based companies. The Governor vetoed the bill.

LWVNM did support, in principle, the Governor's effort to do something about requiring students to be proficient in reading before they can leave the third grade. There were a number of bills that provided early intervention and provided resources to address the problem, but none of them passed. Maybe in the 2013 session we will be able to fully address this issue.

League Day at the Legislature on Jan. 24 was a success with more than 40 League members attending. Our forum the night before on "Voter Verification" was a great success with the room totally packed and great presentations from the four panelists.

Later in the year we will have a function to celebrate the Centennial of New Mexico Statehood. For several reasons, the board decided to postpone the event. Details about the event will be provided later in the year.

We hope to see you at the May 5th Annual Meeting and perhaps at the State Council and National Convention as well.

## ***Los Alamos -- Barbara Calef, President***

Following a consensus meeting on March 5, the Los Alamos League's land use and transportation committee drafted a new position on the environment. The essence of the position is:

\* The League of Women Voters of Los Alamos believes that our natural environment is integral to our community's unique sense of place and to our well-being and prosperity.

\* We support protection of this environment, including the canyons and other open space, vistas, wildlife habitat, and dark skies.

\* We support the use of natural processes to provide services such as storm water management in the built environment for the sake of healthy ecosystems and community livability.

During our program planning meeting League members agreed to continue the study of sustainable land use. Having addressed the issue of the natural environment, the committee still plans to research livability, mobility, and commercial centers.

Regarding the request from LWVUS to make suggestions for the national program, the group supported (and the board approved) a recommendation to request concurrence by LWVUS with the following position on sentencing policy from LWVDC:

1) The LWVUS believes alternatives to imprisonment should be explored and utilized, taking into consideration the circumstances and nature of the crime.

2) The LWVUS opposes mandatory mini-

mum sentences for drug offenses.

Recent speakers for Lunch with a Leader have included

\* Christine Chavez, the Water and Energy Conservation Coordinator for the County. Chavez, who served in a similar position in Las Cruces, explained that utilities in the state are required to file a conservation plan and submit reports with the Office of the State Engineer. In addition to updating the county's five-year conservation plan, she offers free audits of water and energy use to residents, and provides conservation education to the schools.

\* Anne Laurent, Director of Capital Projects and Facilities, has supervised the construction of Pajarito Cliffs (the new complex of county offices and shops), the Justice Center, and the Animal Shelter. Laurent noted that while county policy requires that all public buildings greater than 5,000 square feet be built to a standard of LEED (Leadership in Energy and Environmental Design) Silver, Pajarito Cliffs achieved a standard of LEED Gold!

\* Neva van Peski, Karen Heldmeyer and Jody Larson drove up from Santa Fe recently to share their knowledge about the deficits of the PRC and to discuss how they might be remedied. Contrary to the impressions of some League members, passage of the amendments proposed by the legislature during the recent session will not solve all of the problems. The discussion was intriguing because the solution to some of the problems is not obvious, especially the question of qualifications for candidates for the PRC.

We look forward to our next meeting with our very capable League study leaders.

## ***Santa Fe County -- Judy Williams, President***

The Santa Fe League finalized the study of vote by mail ballots for non-candidate elections. The consensus is that such voting method should be used whenever possible. The position is at [www.lwvsfc.org](http://www.lwvsfc.org).

We decided not to recommend any new studies for next year, as members are already working on three continuing studies: the local courts (including specialty courts), criteria for reviewing local referenda and a study to determine how the

City of Santa Fe should use its undeveloped north-west quadrant. In addition, three local members are working on the state study of the Public Regulation Commission.

LWVSFC has informed the U.S. League that we support a concurrence with the District of Columbia's study recommending review of sentencing laws, specifically minimum sentencing requirements for minor drug infractions.

We have begun review and consideration of the LWVUS privatization study and the consensus questions. The meetings were on March 20 and April 4. Carol Burleson prepared background materials including a summary of the main issues.

In 2011 the Santa Fe City Council adopted a variant of the LWVSFC position on transparency. However, they have been singularly unable to live by it. The latest was the subject of numerous articles in the *New Mexican*. The Santa Fe League has written letters to the city council reminding them of their rule and pointing to the violations.

The league continues to follow the development of the code implementing the new Santa Fe County Sustainable Growth Management Plan. In January we had an opinion article in the *New Mexican* highlighting the need for a strong building code with energy efficiency provisions. In addition, we have urged timely roll-out of the code.

### ***Greater Las Cruces -- Bonnie Burn, President***

All of our current local studies are concluded. On Feb. 1 the Board of Directors approved a concurrence position for Affordable Housing proposed by study co-chairs, Christina Little and Vicki Simons, after unit meetings were held in January. We learned a lot about this issue in Las Cruces and Doña Ana County. We viewed a slide presentation compiled by William Little that illustrated how changed affordable housing has become so that the newer units are no longer distin-

guishable from other housing in a community. The study revealed the great need for affordable housing—approximately 4,700 additional units in Las Cruces and Doña Ana County.

Members of the Board of Education of the Las Cruces Public Schools presented a resolution to us in recognition of the 92nd anniversary of the founding of the League of Women Voters. The complete resolution was published in the March 2012 issue of GLC's *Voter*. We were very impressed with the number of items cited in the "Whereas" sentences that recognized achievements at all three levels of the League. We received great cooperation from the school district administration, teachers, parents and students during our recent study of public education in Las Cruces. This kind of acknowledgement and respect was unexpected and very much appreciated.

March was Women's History Month. The League collaborated with Branigan Library to organize an exhibit that displayed the achievements of Hispanic women. Posters obtained from the Women's History Project (Santa Rosa, Calif.) pictured the women and gave a narrative in English and Spanish about them.

There were several opportunities for increasing League visibility. At the Healthy U, a one-day event, sponsored by the *Las Cruces Sun-News*, the League sponsored a booth where visitors could register to vote or update their voter registration information. We also participated in the Southwest Senior Lifestyle 2012 Expo, a two-day trade show that attracted over 90 community organizations. The League had a booth display where we registered voters and conducted a "straw poll" about issues that would influence voter decisions in November. We also participated in Information Sessions where we presented our studies about affordable housing and public education in Las Cruces and discussed the women's suffrage movement. The theme of the expo was a return to the nostalgic 1950s and concluded with a Sock Hop on Saturday evening. Both events earned revenue for our Education Fund.

## Peggy Hill recounts time with League

Peggy Hill, who will be the keynote speaker at the LWVNM Council meeting, said the following of her experiences with the League:

“I joined the League of Women Voters in Richardson, Texas in 1973 with an infant and a toddler in tow. The League was the smartest group of women I could find, and they could help me become familiar with Texas political situation. Since I’d lived in California up to that time, I felt like I really needed to learn what Texas was like.

“In Richardson, the League members were a wonderful support system. I quickly became a board member and in 1977-1979 I was president of the Richardson, Texas League. Our focus was on recycling, roads and bridges and environmental issues. When we moved to Houston, Texas in 1979, the Houston League members were on my doorstep to help me unpack and become involved in the Houston Area League. For two years I ran “Election Central,” which was the way we had then to report election outcomes immediately.

“During the 1980’s, while I worked on my

doctorate, I was unit chair, served on the board and helped with education studies.

“In 2010 I was invited to serve on the National Board for the League of Women Voters, and that was the year that the Education Study was selected as one of two national studies. Working on the education study for the past two years has given me additional in-depth knowledge of national education issues. With a very professional team of seven other League members from across the country, we researched, wrote, reported, developed and analyzed the consensus and finally wrote the national education position. This is the first time in the history of the League of Women Voters there has been a national position written on education.

“Being a member of the League of Women Voters has been a 40-year journey for me, educating me, guiding me and nurturing me in so many ways. I’ve learned to run effective meetings, to understand how critical a strong well-educated electorate is and how important our voter service is to the entire community in which we serve.”
